Official Rules

The sweepstakes begins at 9:00 am EST on 08/14/2023 and ends at 5:00 pm EST on 09/30/2023 ("Promotion Period").

1. **TO ENTER:** During the Promotion Period, visit <https://kinsmithloans.com> and follow the directions for online entry. Alternatively, during the Promotion Period, visit a participating Kinsmith Finance affiliate retail location (see the affiliate list below), complete an official entry form, and deposit it in the sweepstakes entry box.
